- 1. Full payment is required for all vendors upon submittal of completed application. Booth locations will be determined after receipt of completed application and full payment.
- 2. Spaces are first come, first served.
- 3. Exhibitor space is non-transferable.
- 4. Cancellations: 2 weeks prior to event incurs a 50% cancellation fee. 1 week prior to event incurs a 75% cancellation fee. No refunds will be made to vendors who do not attend the event.
- 5. It is agreed that Southland Events, LLC or any affiliated companies or individuals are not liable for any injuries, or responsible for any lost, stolen or damaged items.
- 6. Upon submission of agreement, Southland Events, LLC will provide vendor with all sales and health permit information. It is the vendor's responsibility to make payment on and acquire such permits and follow all respective permit rules and regulations.
- 7. Sponsor agrees that it will defend, indemnify, and hold harmless Southland Events, LLC, its owners, employees, officers, directors, agents, and volunteers from any claims, actions, or causes of action in any way arising from this agreement or from any Event arising from this agreement, regardless of fault. Sponsor additionally agrees to maintain a policy of general liability insurance of not less than \$1,000,000, and to name 'Southland Events, LLC' as additionally insured.
